**BOARDING CONTRACT**

This is a contract between ALMOST HOME PET RESORT, INC. (AHPR) and the pet owner whose name is on the reverse side of this contract (herein called owner). This contract applies to **EVERY TIME** your pet is in the care of ALMOST HOME PET RESORT.

1. Owner agrees to pay the rate for boarding and grooming in effect on the date the pet is checked into AHPR (as posted in the reception area and for the correct weight of the dog).
2. Owner further agrees that the pet shall not leave AHPR until all charges are paid or arrangements have been made for payment with permission from Betsy Hicka or Jennifer Tumolo. Owner further agrees to pay for all costs and charges for any special services requested, and all veterinary costs for the pet during the time said pet is in the care of AHPR.
3. By signing this contract and leaving his/her pet with AHPR, owner certifies to the accuracy of all information given about his pet on the reverse side of this contract.
4. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances. Owner specifically represents to AHPR that the pet has not been exposed to Rabies or Distemper within a 30 day period prior to boarding.
5. In accepting your pet(s) for boarding or grooming, we promise to exercise due care to protect its (their) attention. AHPR will not be liable for death or damage caused by, but not limited to the following: any pre-existing condition, whether known or unknown, that causes illness or disease, organic failure, jumping or scaling fences, running away, loss due to theft, fire, acts of God, or any other unavoidable or unforeseeable causes. AHPR will not be responsible for any fleas or ticks noted on the pet after 10 minutes of leaving the facility. The owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of AHPR and Owner agrees to pay costs of any property damage and/or personal injury caused by said pet during its stay at AHPR. It is expressly agreed by the Owner and AHPR that AHPR's liability shall in no event exceed the sum of \$250.00 per animal boarded.
6. If the pet becomes ill or if the state of the animal's health otherwise requires professional attention, AHPR shall, in its sole discretion, engage the services of a Veterinarian (either the pet's own or one in close proximity to AHPR), or administer medication or give other requisite attention to the animal and the expenses thereof shall be paid by the Owner.
7. All charges incurred by the Owner shall be payable upon pick-up of the pet and if an extended stay is desired, charges to date plus a weekly deposit are to be paid. If the pet is not called for within 10 days after the scheduled check-out date, said pet may be sold or disposed of at our discretion, and from the proceeds of said sale, will be deducted all fees and charges under this contract, plus all costs incurred in the collection of these charges including reasonable attorneys' fees. Notice of sale or disposal will be given by a registered letter to the owner's last known address according to our records at least 10 days prior to such action being taken. No further notice shall be given.
8. This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and AHPR.
